**October 22, 2025**

A meeting of the Salary & Labor Committee was called to order at 9:00am on October 22, 2025 in room 250 with the following members present: Tom Walsh, Michael McEmery, Kathy Bright, James Bailey, Steve Aubry. Webex: Tina Busch Absent: Joe Oscepinski

**No Citizen Comment.**

**Motion** by Mike McEmery and 2<sup>nd</sup> by James Bailey to approve the minutes from the previous meeting. All Ayes, Motion Carried.

**Comment:** Sheriff's Dept, PT Telecommunicator positions and Amendment to the EO Contract for Sheriff's Dept, Telecommunicators.

Attorney Adams presented a brief update regarding the current discussion on PT Telecommunicator positions as well as the consideration of movement from 8hr shifts to 12 hr shifts. He is currently in discussion with AFSCME on language, it is not yet final. He believes that once this is completed, both items will be taken care of, most likely by the next committee meeting in November. He and the Sheriff's office will follow up with the committee when an agreement is reached.

**Comment:** Hazard Pay for Maintenance Dept Employees

Attorney Adams presented on behalf of the Maintenance Dept and Property Committee. He reviewed a situation in the Detention Home where a plumbing problem occurred due to a resident flushing an item and causing water flow problems; result was sewage backup and an immediate need to temporarily fix until a contractor could arrive to repair. Attorney Adams explained to the committee that a side letter for hazard pay was in existence with a sunset clause; believed it should have been written into regular contract language during the most recent renewal, however was missed. The request is to make the employees whole due to their belief that the hazard pay still remained effective, that the error in omission was clerical in nature and that the employees be compensated at the hazard pay rate of \$10/hour for hours worked per incident. The current request would be for 21 hours per employee at \$10 per hour.

The committee asked questions, however took no action at this meeting; requesting Attorney Adams to return with further information in November.

**Comment:** Chief Deputy Auditor Compensation

Auditor Thompson requested to discuss the position of Chief Deputy Auditor for her department. The committee stated that the topic would be tabled after discussion included the Finance committee review of the presented budget earlier in the week as well as duties of the said committee in relation to the request presented.

The committee took no action at this meeting.
