Due to difficulties we have after issuing liquor licenses, it seems to appear Licensees are not familiar with the LaSalle County Liquor License Rules until some infraction occurs. With every application, Licensee(s) are issued the "*LaSalle County Rules & Regulating of the Retail Sale and Consumptions of Alcoholic Liquors in the Unincorporated Areas in the County of LaSalle, Illinois*" (Ordinance #16-122 dated 9-12-16 amended Ordinance #17-158 dated 11-2-17) Manual; it is the licensee(s) responsibility to read and adhere to these rules.

Please understand, LaSalle County Liquor Commission has the authority to issue License and enforce the rules and regulations of the Liquor Resolution. LaSalle County Liquor Commission is not required to see that Licensee make a success of any business ventures, however this is our desire.

**ALL APPLICANTS, OFFICEHOLDERS, MANAGERS SHALL READ AND SIGN A COPY OF THIS FORM; Upon Signing You Are Stating That You Understand The Following And Shall Adhere To** "*LaSalle County Rules & Regulating of the Retail Sale and Consumptions of Alcoholic Liquors in the Unincorporated Areas in the County of LaSalle, Illinois*" (Ordinance #16-122 dated 9-12-16 amended Ordinance #17-159 dated 11-2-17 amended Ordinance #17-158 dated 11-2-17) **Manual:**

As an example some of the most common infractions are listed below:

1. **No License shall be transferable** (Ordinance #16-122 date 9-12-16 amended Ordinance #17-158 dated 11-2-17, Section Four: Nature of License/Transferability)
2. **No alcoholic liquors shall be sold, given or delivered to any individual under the age of twenty one (21)** (Ordinance #16-122 date 9-12-16 amended Ordinance #17-158 dated 11-2-17, Section Five: Eligibility for License, x); Section Thirteen, Underage Restrictions)
3. **Hours of business are: - DOES NOT INCLUDE BEER GARDEN PERMITS**  
7:00 a.m. to 2:00 a.m. - Monday, Tuesday, Wednesday and Thursday  
7:00 a.m. to 3:00 a.m. - Friday and Saturday  
8:00 a.m. to 1:00 a.m. - Sunday  
(Ordinance #16-122 date 9-12-16 Amended Ord #17-158 dated 11-2-17, Section Eighteen: Hours of Sale [(a-h)])
4. **Only persons allowed on premises from closing hours to opening hours shall be Owner, Licensee and anyone doing clean-up.**  
(Ordinance #16-122 date 9-12-16 Amended Ord #17-158 dated 11-2-17, Section Eighteen: Hours of Sale, [(a-h)])
5. **No Licensee shall permit any disorderly conduct or loud and unusual noises. This includes any unreasonable loud noises or unreasonable conduct that acts to alarm or disturb residents or businesses located in the vicinity of the licensed premises.** (Ordinance #16-122 date 9-12-16 amended Ordinance #17-158 dated 11-2-17, Section Nineteen: Noise)

These are just a few of the infractions that occur. With the signing of this document, Licensee is still obligated to read and understand the *LaSalle County Rules & Regulating of the Retail Sale and Consumptions of Alcoholic Liquors in the Unincorporated Areas in the County of LaSalle, Illinois* (Ordinance #16-122 dated 9-12-16 amended Ordinance #17-158 dated 11-2-17) which includes *LaSalle County Beer Garden Permit* in its entirety.
