This is an intermittent part-time position that may require employees to be on call for a minimum of 2-4 shifts (12-14 hours) a month and work nights, weekends, and holidays. Employees must be able to respond to a call within twenty (20) minutes. Living in LaSalle County is required, and employees must have reliable transportation.

The Deputy Coroner shall support the Constitution of the United States and the Constitution of the State of Illinois and shall faithfully discharge all of the legal and mandated duties of the office of Coroner. The Deputy Coroner's responsibilities include, but are not limited to, going to the place where a dead body is, take charge of same including any valuable personal property, money or papers found upon or near the body, make a preliminary investigation and written reports into the circumstances of the death, and attempt to ascertain the cause of death, either by autopsy or otherwise. The Deputy Coroner shall be a conservator of the peace and provide support to the coroner including addressing the needs of family members, law enforcement personnel, funeral home personnel, tissue/organ donor banks, insurance and attorney's offices, and other citizen inquiries.

Conducts Medicolegal Death Investigation which includes:

- Respond to death scenes, hospitals, and nursing homes, to determine probable cause and manner of death and necessity for autopsy or further examination.
- Obtain and secure biological samples, specimens, and bodily fluids for laboratory analysis.
- Analyzes collected evidence and manages the personal belongings of the deceased, ensuring proper documentation and disposition in accordance with legal and departmental guidelines. Must maintain absolute integrity, privacy, and honesty.
- Make positive identification of the body by whatever professional means necessary.
- Complete Preliminary Investigation Reports and other forms and reports as mandated by law and/or directed by the coroner.
- Searches for, locates and notifies next-of-kin or responsible party to communicate circumstances of death.
- Complete follow-up contacts with next of kin or responsible party concerning cause of death, impending proceedings, and other concerns.

Examples of Duties

- Respond to telephone requests and inquiries from family members, medical personnel, funeral directors, hospice/home health care personnel, law enforcement officials, attorneys, and the general public
- Testify in civil and felony court, or at any other legal proceedings when subpoenaed to do so or at the request of the State's Attorney's Office
- Participate in both mandatory and recommended accredited training programs including in-service training.
- Assist with office duties as needed as well as other duties assigned by the coroner and/or chief deputy.
- Complies with all policies, and procedures contained in the LaSalle County Coroner's Manual and also with the guidelines of the Illinois Coroner and Medical Examiners Association.

- Maintain absolute confidentiality of work-related cases, records and health information.
- Performs all job tasks within the rules and guidelines of the County's Safety Policy and Employee Handbook Manuals.
- Arrange for transport of body by funeral service or transporter.
- Complete record of death and other forms as required, by writing abstract of medical history and narrative report detailing circumstances of death, findings, and actions taken. This information will be loaded in a software management system.
- Attend forensic autopsies for decedents.
