ORDINANCE #18-129 PREVAILING WAGES

WHEREAS, the State of Illinois has enacted "An ACT regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works", approved June 26, 1941, as amended, being Chapter 820 ILCS 130/1-12, Illinois Compiled Statutes, and;

WHEREAS, the aforesaid Act requires that the COUNTY OF LASALLE investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of the COUNTY employed in performing construction of public works, for the COUNTY, and;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY BOARD OF LASALLE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works" approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of this COUNTY is hereby ascertained to be the same as the prevailing rate of wages for construction work in the COUNTY area as determined by the Department of Labor of the State of Illinois as of June of the current year, a copy of that determination being attached hereto as Exhibit "A" and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by LASALLE COUNTY. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said Act.

SECTION 2: Nothing herein shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works of the COUNTY OF LASALLE to the extent required by the aforesaid Act.

SECTION 3: The LASALLE COUNTY CLERK shall publicly post or keep available for inspection by any interested party in the main office of this COUNTY this determination of such prevailing rate of wage. A copy of this determination or the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4: The LASALLE COUNTY CLERK shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed, or file their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.




